To those who truly care about children:

██████████ was a healthy 7-year-old girl. Did she get the covid vaccine the week that the vaccine clinic bus was parked in front of your school she attended? That's the same week she died.

If you didn't know that the covid vaccine is harmful to some children, forgive yourself for ██████████'s death. You may have promoted the covid vaccine to children, who are not in danger from covid, but if you didn't know of the harm from vaccines, forgive yourself. If you were indoctrinated by the "common wisdom of the local culture" or by the news media, or by politicians, forgive yourself.

But now that you do know how dangerous this vaccine is, if you remain silent, and other children are then harmed, self-forgiveness will escape you, and guilt from silence will forever be present.

It is understandable that you were convinced that this faux vaccine is safe. I doubt you ever heard expert immunologists yelling from the beginning about the danger of injecting children with experimental technology never before used in humans at a population level. The media called the best immunologists "quacks" while they trotted out non-practicing TV News Doctors. When the government, politicians, media, and local physicians call it "safe and effective", an average person hardly has a chance to discern truth. Only experts and cynics stand up to such "common wisdom" recklessness. So, forgive yourself.

A vaccine adverse event was reported to VAERS on January 15, 2022 for a 7-year-old girl from Massachusetts who was vaccinated on January 13, 2022. ██████████ died on January 18. Channel 5 News said she "died of covid." The covid vaccine clinic bus was at the school that week. We have a responsibility to all other children to ensure the covid vaccine is investigated as ██████████'s possible cause of death. Since ██████████'s death January 18, 15-year-old ██████████ died on a MA basketball court on February 27. Not one media outlet in Massachusetts has mentioned or speculated about the cause of his death. It is eerily silent as if it is not to be mentioned in the news. Why?

If you think covid vaccine deaths and injuries are rare, that is because the media hides the truth. ██████████ died of myocarditis in Mass General Hospital at 20yo on December 22, 2021. ██████████, of ██████████, MA, 42yo wife and mother of two young boys died September 13, 2021. In early June 2021, her brother, ██████████, posted on social media that he was worried about his sister, ██████████, because she was bleeding internally for some reason. ██████████ did not attend ██████████'s funeral in September

because he died unexpectedly on June 29, 2021, three weeks after he posted his concern for his sister. The [REDACTED] parents lost both their children in 2 months unexpectedly and in the prime of their lives.

I can fill many pages of true stories like these in Massachusetts. They all can be verified. You should know of a letter from the CEO's of the American Board of Internal Medicine, American Board of Pediatrics, and American Board of Family Medicine to all physicians in Massachusetts stating that "the Federation of State Medical Boards (FSMB), which supports its member state medical licensing boards, has recently issued a statement saying that providing misinformation about the COVID-19 vaccine contradicts physicians' ethical and professional responsibilities, and therefore may subject a physician to disciplinary actions, including suspension or revocation of their medical license." There is no precedent for such a chilling message to be sent from national boards to all physicians. This letter is clearly a threat to keep quiet about any covid vaccine deaths else they will end the careers of those physicians.

You should also know that if a death is labeled "covid", then the funeral costs are covered by the government, but not if the death is labeled a vaccine injury. People in grief understandably take the advice of funeral directors, and the covid vaccine is not mentioned in the obituaries. Ask a funeral director what they've seen throughout 2020 and 2021 and if it matches the news you're fed on TV.

Self-forgiveness begins with truth. What happened to [REDACTED]? As long as truth is hidden by media disinformation, medical board threats to physicians, and financial incentives to mislabel deaths, more people will be injured or die many years before their natural time. Government and pharma depend on silence. Silence becomes complicity. Complicity leads to guilt and confounds self-forgiveness.

Maddie de Garay did not deserve to be wheelchair-bound for life after this experimental vaccine at 12yo. Simone Scott did not deserve to die of heart failure at 19yo after it destroyed her heart and the heart transplant failed. Jacob Clynik did not deserve to die in his sleep at 13yo from the vax. Again, I can fill pages of these. Losing a child is devastating. I ask you to make a simple demand for investigation. Send an e-mail to the DA. Don't let this be swept away like thousands of others have been. Did [REDACTED] die from vax, but was labeled a covid death (double fraud)?

I don't know for sure what happened to [REDACTED]. If [REDACTED] was vaccinated on January 13 at school and died on January 18, **you have a moral obligation to demand investigation**. Demand the autopsy records be made public. Be righteous. Grieving parents can be manipulated into silence, but you can make a difference before children are coerced to get a third shot that leaves more families devastated.

Healthy children are not in danger of dying from covid despite what false news programs tell you. The data is clear. CDC data and the best scientists in the world agree. All I ask is that you demand that the covid vaccine be investigated as the cause of [REDACTED]'s death. Do not live with the guilt of remaining silent. More deaths happen every day around the world because too few speak up.

There will be grand jury investigations and indictments for hundreds of thousands of deaths due to this vaccine. The truth will come out. The data is now irrefutable. Do not wait. Demand to know now.
